Joins and Duplicates among the Boğazköy Tablets (21–30)

by Jared L. Miller – Mainz

During my recent work on Keilschrifttexte aus Boghazköi 50, 53 and 57, I was able to find a further series of joins and duplicates.¹ Nos. 21–22, 24–26, 28 and 30 I was able to collate, join (when applicable) and photograph in Ankara in the summers of 2005 and 2006.² All of the tablets in question come from Temple I, except for No. 27, the provenience of which is unknown, and No. 29, which comes from Büyükkale, Building E. All fragments show a New Hittite script.

21) 305/v, hitherto booked in the online Konkordanz (www.hethiter.net) as CTH 237³, in fact belongs to KUB 4.95(+)KBo 28.45 (CTH 170), a letter from Ramses II to Tešub-Šarrumma; cf. E. Edel, ÄHK I (1994) 44–47 (Nr. 16) and Taf. X–XI, whereby it is once again seen that extensive restorations, in this case even when parallel documents are available, are generally wrong or inexact.³

27) IBoT 2.110+20/r joins with a fragment labelled in the archives of the Akademie der Wissenschaften und der Literatur, Mainz, as 'Privat Berlin', and registered in the online Konkordanz as 'Privat 57' (CTH 404.1, Ritual of Mastigga against Family Quarrel). Since Privat 57 duplicates IBoT 2.109 of 404.1.II.B the join requires that IBoT 2.110+20/r, traditionally supposed to be part of 1.II.B,⁸ be disjoined from it and, along with Privat 57, either attributed to one of the other tablets or set alone; cf. J. L. Miller, StBoT 46 (2004) 23, 52f., 83f. As its script is NH, it cannot belong to any of the MH 1.I versions; it duplicates 1.II.A, 1.II.B, 1.II.C₂, 1.II.D₂ and 1.III; and it has a very different handwriting than 1.II.E and would appear to have a rather different script than 1.II.D₃ and 1.II.G. The remaining candidates would be 1.II.C₁, 1.II.D₁ and 1.II.F.
